I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM ASSUMING RISKS AND AGREEING TO INDEMNIFY, NOT TO SUE AND RELEASE FROM LIABILITY THE ORGANIZER OF THIS EVENT AND THE UTE PASS SADDLE CLUB, ITS ASSOCIATIONS AND THEIR RESPECTIVE AGENTS, EMPLOYEES, VOLUNTEERS, MEMBERS, CLUBS, SPONSORS, PROMOTERS AND AFFILIATES (COLLECTIVELY "RELEASEES", AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS. THIS RELEASE IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES AND IT APPLIES TO ALL ACTIVITIES ENTERED AT THE EVENT, REGARDLESS WHETHER OR NOT LISTED ABOVE. I HAVE READ IT CAREFULLY BEFORE SIGNING AND I UNDERSTAND WHAT IT MEANS AND WHAT I AM AGREEING TO.

In consideration of the issuance of permission to participate or my acceptance of my application to entry in the above event, I hereby freely agree to and make the following contractual representations and agreements:

I, _____ understand the potential dangers and risks associated with activities involving equines (horse, pony, mule, donkey, hinny), including without limitation, mounting, riding, leading, walking, feeding, grooming, competing, riding in public events riding in parades and being in their presence. I understand that all horse-related sports and related activities I may participate in sponsored by or related to the Ute Pass Saddle Club carry a risk of serious physical injury and even death. Understanding those dangers and risks, I do hereby advise, represent and warrant to the Ute Pass Saddle Club, and their respective officers, directors, shareholders, members, employees, agents, affiliates and anyone else directly or indirectly connected with them (collectively, the "Releasees") that I do hereby release the Releasees and hold each and all of them harmless from and against any and all liability of whatever nature and severity (including death) in the event of any injury or damage of any nature to me or anyone else caused by my electing to participate in and/or observe equine activities associated with the Ute Pass Saddle Club EVEN IF THIS INJURY IS DUE TO NEGLIGENCE OR CARELESSNESS ON THEIR PART. I also assume full responsibility for any damage or injury (including death) caused by me or my horse, pony, mule, donkey or hinny, to any other person or property while engaged in any Ute Pass Saddle Club related activity.

The release and promise to hold the Releasees and those connected with them harmless offered and represented by this Release and Hold Harmless Agreement shall be binding not only upon me, but also upon my heirs, my personal representatives and legal representatives, and anyone who could or does claim an interest through me. I agree to maintain medical insurance, including major medical insurance, sufficient in my opinion to adequately cover myself and my family during any activities of Ute Pass Saddle Club. If I choose not to hold insurance, I in no way hold the Ute Pass Saddle Club responsible for providing it. I recognize that the services of Ute Pass Saddle Club and its volunteers will be provided only in reliance of this waiver and related covenants herein.
