By my signature below, I certify that I have read, understand and accept the following representation, stipulations, and waiver. I understand that I am being considered for a volunteer position with The Woodland Park Saddle Club and that I am not entitled to any benefits of employment or any of the rights and guarantees afforded to The Woodland Park Saddle Club employees or contractors. I understand that my position as a volunteer can be terminated at any time, for any reason, and that I have no legal right to continued participation as a volunteer. I further understand that The Woodland Park Saddle Club, The Woodland Park Saddle Club Complex, property owners, or lessees will not accept financial or legal liability for any injury or occurrence arising from Woodland Park Saddle volunteer activities and that accordingly, my participation in such activities must be at my own risk.

I understand that my operation of any type of vehicle subjects me to all laws and requirements respecting operation of that vehicle, and I agree to abide by all applicable laws. I agree that I shall not operate a personal vehicle for volunteer activities unless I have at least the minimum amount of liability insurance required by Colorado law. I will obey all safety rules and speed limits with no exceptions. I expressly assume financial and/or legal liability for all risks of injury to persons who accompany me on these activities, including family members, guests, friends and acquaintances, and all other persons who accompany me. I agree to abide by all of the policies and procedures of The Woodland Park Saddle Club. In the event that information from the report is utilized in whole or in part in making an adverse decision with regard to your potential or continued volunteer work with The Woodland Park Saddle Club, before making the adverse decision, we will provide you with a copy of the background report and a description in writing of your rights under the law.

Please be advised that we may also obtain an investigative report including information as to your character and general reputation. This information may be obtained by contacting your previous employers or references supplied by you. Please be advised that you have the right to request, in writing, within a reasonable time, that we make a complete and accurate disclosure of the nature and scope of the information requested. Such disclosure will be made to you within 5 days of the date on which we receive the request from you or within 5 days of the time the report was first requested.

The Fair Credit Reporting Act gives you specific rights in dealing with consumer reporting agencies. You will be given a summary of these rights together with this document.

By your signature below, you hereby authorize us to obtain a background report and/or an Investigative Report about you in order to consider you as a volunteer, and if applicable, to consider you for continued volunteer work once you begin with The Woodland Park Saddle Club. You hereby authorize your current and former employers, other organizations you have worked for, including volunteer work and associations you have participated in to provide this information to us.
